Thank you for agreeing to serve as a public health consultant for Avahan, our foundation's initiative in India to fight the HIV/AIDS epidemic. As we discussed in our meeting, the Gates Foundation has begun Phase II of the Avahan project by committing an additional \$200 million to expand its efforts in India. In your role as consultant, you will be able to help us survey the current anti-AIDS campaigns in India (not only those by Avahan, but also by the other governmental and non-governmental organizations that are working on this epidemic) and then identify where and how this new \$200 million donation could best be invested.

Your report will help us determine what is working in India, what hasn't been successful, and what strategies exist that we still haven't tried, or haven't had the resources for. We'd also be interested in your analysis of effective anti-AIDS campaigns in other developing nations. As we mentioned in our meeting, we're especially interested in seeing what we can learn from nations like Uganda and Thailand, which have been recognized for their success in this area.

Thank you for making the time to help us with this evaluation; we know that you share our belief that the fight against HIV/AIDS in India is one of the most important public health efforts of the 21st century.
